- 1.** Musgrave reserve the right to refuse admission should the customer using the Staff-Pass voucher not provide all the necessary documentation. Providing proof of place of employment* is essential to admittance.
- 2.** MWP must comply with AML requirements under the Criminal Justice (Money Laundering and Terrorist Financing) Act 2010 as amended (the "CJA") in respect of all Relevant Transactions, including the carrying out of customer due diligence (i.e. identification and verification of a customer's identity) ("CDD") and ongoing due diligence (i.e. ensuring the CDD collected is reviewed periodically and kept up-to-date) ("ODD"). Therefore, card is the preferred method of payment but if paying by cash then we will require a utility bill which we will photocopy as proof of address, along with a photocopy of your photo ID.
- 3.** Staff-Pass Customers are offered a Staff-Pass as an added "perk" as a direct result of being employed by a valued fully registered customer of MWP only.
- 4.** Staff-passes are non-transferable and may be cancelled at MWP's discretion.
- 5.** Staff-Pass accounts must not be used for trade purchases by the employer, they must continue to use their trade account.
- 6.** Staff-Pass Customers are not permitted to use any goods purchased in Musgrave MarketPlace for commercial or illegal purposes;
- 7.** Tobacco purchases for resale are strictly prohibited on this account as customers buying tobacco for resale must provide a registered Facility ID under Tobacco Track & Trace requirements. Therefore a reasonable quantity deemed for personal use is limited to 5 cartons
- 8.** Staff pass purchases must comply with Wholesale Liquor Licencing and Medicinal Licencing rules. Medicinal products are not for sale to SME customers.
- 9.** Activity on these Staff-Pass accounts will be monitored and any inappropriate use will result in closure of the account/termination of the Staff-Pass offer.
